If you choose to set up on Thursday, August 1, you must do so between the hours of 9am and 12 NOON, NO EXCEPTIONS! Cars and/or trucks must be out of the area by 1pm. Police will enforce. Food Tents & Trucks must remain onsite for duration of the festival.**

I agree to be open during all hours of the event and offer only the items from above that are approved by HBP. I will keep my area clean. All vendors must supply their own TABLES, LIGHTS and OUTDOOR extension cord. **If you are using frying oil, you MUST be sure not to spill it on the ground when cooking. When the event is over you are required to dispose of it on your own. If there are any remains on the ground, the Borough will be issuing fines and your security deposit will not be refunded. HBP is not responsible if you receive a fine.** I understand that all decisions made by HBP Events committee are final. Failure to abide by the above rules could terminate my relationship with HBP and any other HBP events and no refunds will be made. There is a \$40 fee for returned checks.
