Guest Introduction & Summary:

Michael Salerno is from originally from Middletown and now resides in Rumson with his wife and two children. He currently owns about 10 properties on Bay Avenue. He had a vision years ago and saw opportunity in Highlands, which was why he began to accumulate properties. He hasn't done much with them as he is waiting to see how to best development them in alignment with the towns' plans. He sees Highlands as a "Sea Shanty" town with recreation, and nostalgic history. He could also envision Bay Avenue to be somewhat like New Hope with smaller local retail shops mixed with restaurants. He said his vision is not as important as what Highlands has for a vision. When he knows what that is, he can determine the best course for development of his properties.

Some of Mike's current project include: Long Branch on Ocean Avenue near Cooper Avenue; 170 units on 5 acres which he owns with partners, intended to be an adjunct to The Lofts. His project in Red Bank will create a new retail environment for smaller businesses that are enclosed kiosk spaces at approximately 400 square feet each. Mike spoke about how the building plans were modified to include a parking deck as well. While Mike considers himself a developer, he also has a fiduciary company with offices in 5 states. Mike is also collaborating with Valerie Montecalvo, looking at options to work together to help with the development of Bay Avenue.

- Mayor Broullon stated that most of her points were discussed in the conversation prior to start of Agenda.
 - She noted the changes that have been made to parking requirements for businesses on Bay Ave that are more favorable for new businesses, which in-turn is best for the community.
 - Plan to better accommodate the 1st Aid Squad's need for a new location. The current building is owned by the Fire Department. After the new Borough Hall building is built, and the trailers are removed, there will be a new 2 story building built for the 1st Aid Squad next to the HBP shed.

Event Recap:

- Seaport Craft Show \$3185 was generated in income and the expenses \$1,010
- Fluke Tournament Thank you to Geoff Pierini, Captain's Cove, Nancy Burton & Family, Russ & Karen Chelak and Bob & Cindy Davis for a great job. The event grossed \$4161 and the expenses were \$3990. The event is expected to grow and will be advertised well in advance. It was late launching.
- 10th Annual Taste of Highlands Income was \$4,280 and the expense was \$468
- Clam Festival currently showing a loss with the expenses \$42,217 and the income was \$39,564. We still have not received the fireworks sponsorship of \$2500 for fireworks but may have a \$1000 profit. We also have inventory of sangria & white claw to sell at Oktoberfest. We were very leery to hold the event with so little time but it really turned out well considering it rained for 1 of the 3-day event.
